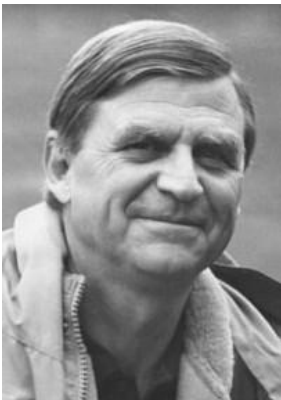

Thomas S. Knight, Jr. died peacefully at his Greenwich, CT home Sunday morning shortly after midnight. Knight was born in Rochester, NY on May 9, 1930. Shortly thereafter he travelled to Europe where he met his future wife of forty-eight years, Kathleen Craig, while they waited together in line to collect mail at the American Express office in Paris. He served his country in Korea during the War as a 2nd lieutenant in the United States Army with the 555th Field Artillery Battalion. Upon his return from active duty he began a career in advertising with Young & Rubicam in New York, where he was as an account executive for over twenty years ultimately retiring from advertising with the firm E.

B. Wilson. In addition he was a board member of PNC New England Bank. An avid hunter, fisherman, and golfer, Knight pursued those hobbies throughout his life and was on the Board of Directors of the Round Hill Club and the Trout and Salmon Foundation. 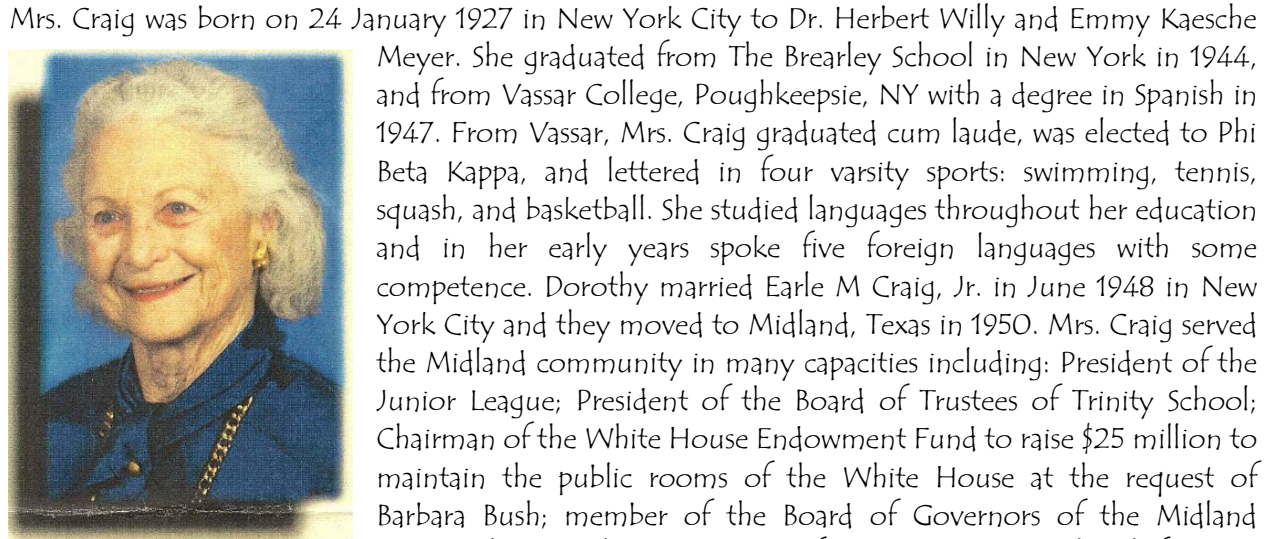

Earle M. Craig, Jr., age 84, passed away on 20 November 2008.



Mr. Craig was born on 26 March 1924 in Rochester, PA to Mr. Earle M. and Margaret Peters Craig. His childhood was spent in Beaver, PA near Pittsburgh. He graduated from The Lawrenceville School, Lawrenceville, N.J., in 1942 and from Yale University, New Haven, CT with a B.S. degree in Applied Economics in January 1949, in the class of 1945W.

Mr. Craig enlisted in the U.S. Army Air Corps. Reserve in September 1942, and graduated from Single-Engine Flying School as Second Lieutenant and rated Pilot at Eagle Pass Army Air Base, Texas in the Class of 1944B. He trained in P-47 Single-Engine Fighters at Bruning, Nebraska, and Abilene and Dalhart, Texas. Mr. Craig flew escort, dive-bombing, napalm bombing, and strafing missions in P-47's as a First Lieutenant and Flight Leader in the 507th Fighter Group, 463rd Fighter Squadron from Ie Shima, near Okinawa, in July and August 1945. He witnessed the Nagasaki atom-bomb explosion from his airplane on 9 August 1945. Mr. Craig was commissioned Captain in the Eighth Air Force in January 1946 and released from active duty in October 1946. He returned to Yale University and graduated in January 1949.

Earle married Dorothy Elsie Meyer in June 1948 in New York City and they moved from Sewickley, PA to Midland, TX in August 1950. Mr. Craig was self-employed as an independent oil and gas producer from 1950 until the present doing business as Craig, Ltd. and Earle M. Craig, Jr. Corporation.

Mr. Craig's volunteer service included: Chairman of the Board of Deacons and later elder of First Presbyterian Church of Midland where he had been a member for over 50 years; Director of Midland National Bank and its successors; Trustee of The Lawrenceville School, NJ; Trustee of the Nantucket Conservation Foundation; Trustee of the Siasconset Union Chapel, Nantucket Island, Siasconset, MA; Trustee of the Nantucket Historical Association; and he was selected as one of Midland's Centennial Citizens in 1985 by the Leadership Midland Alumni Association. He was also a member of the Order of Indian Wars. Mr. Craig was also very active in the Republican Party both locally and at the national level.

83. Al was born in Sew-
ickley, PA, on April 19,
1924. He was the son of

G. (Gibson) Craig. He attended The
Lawrenceville School and Princeton Uni-
versity and Cornell Medical School
(1948). He served as a Lieutenant and
Research Physician in the US Army
Medical Corp, 1951-1953.

His long career as a Professor of Phys-
iology and Pharmacology at the Univer-
sity of Rochester Medical School took
him to Japan, Nigeria, Hawaii and Nor-
way on a Fulbright Fellowship. His car-
eer reflected a lifelong personal and
professional passion for the sport of
swimming. He was author or co-author
of over 100 papers covering a range of
physiology related topics. He continued
his research into the biomechanics of
swimming as Professor Emeritus of
Physiology until his death. In addition to
editorial board memberships on numer-
ous academic publications, he was Pres-
ident of the American College of Sports
Medicine (1972-73) and The Staunton
Farm Foundation of Pittsburgh, PA
(1985-1991). He authored *One Woman's
Dream, a Brief History of Staunton Farm
Foundation* and *Burchfield-Craig: Two
Pittsburgh Families*.

Al's deep respect and affection for na-
ture and the Finger Lakes region was re-
flected in his long time support of the
Finger Lakes Land Trust and his part-
time residence for many years in
Canadice, NY. He also served as a
member of the Planning Board and
Comprehensive Planning Committee of
the Town of Canadice, NY.

Overview, STAUNTON section [pgs. 9-10, 24-25]

[My source for all Chester, England data is the Chester church records, both Church of England/Anglican and Non-Conformist/Dissenter.]

- Pg. 9, chart and 3rd paragraph; pg. 217, 5th paragraph; pg. 222 – The full name of William Staunton [b. 1803] is “Rev. William Stanton/Staunton, D.D.” He did not have a middle name of “Armitage”.
- Pg. 9, chart; pg. 10, 2nd paragraph, line 13; pg. 217, 221, 223 & 237 – Henry Staunton was born on 11 May 1823 and died in Sep 1823, so he had no wife or child.
- Pg. 9, 1st paragraph, last sentence – However, we now [2015] have information on two additional generations previous to what appears in this book *[see below]*.
- Pg. 9, 2nd paragraph, last line – should be William Staunton, not William Craig.
- Pg. 9, 3rd paragraph, 3rd line – Rev. William Staunton was an *Episcopal* minister, not a *Presbyterian* minister.
- Pg. 10, 1st paragraph – Revise to read “William Staunton remarried twice after his 1st wife’s death. The 2nd and 3rd wives, and the 3rd wife’s son, died shortly afterwards. He then remarried once again just after they left Chester...His fourth wife was Mary Evans...”
- Pg. 10, 1st paragraph – Mary Evans had definitely been his housekeeper. Rev. William Staunton, D.D. states this directly in his “Genealogical & Historical Notices”. Edwin Staunton’s version of this [pg. 93] differs from Rev. Staunton’s original, in his own handwriting, that I have in the Staunton Family Archives. There are about 26 lines that are “missing” in Edwin’s version, where Mary’s role as housekeeper is stated. Interestingly, you also quote Edwin on pg. 217, in paragraph 5, with part of the information contained in the “missing” 26 lines.
- Pg. 24, note 21, line 1 – “excerpted” should read “excerpts”.
- Pg. 24, note 21, 4th paragraph – Revise to read “I find it curious, as well as surprising, that Rev. Staunton never mentions the addition of two other wives, and two other babies, and the death of those wives and one of the babies, even though, at the ages of 9-11, he would certainly have been aware of them in his household.”
- Pg. 24, note 21, last paragraph; pg. 217, paragraphs 3-5 – There is no known connection between Thomas, the son of William and Mary Evans Staunton, and “Joseph Staunton” in the 1840 census records.
- Pg. 25, note 22 – According to the “Philadelphia Passenger Lists, 1800-1945”, the Stanton family sailed from Liverpool to Philadelphia on the “Lancaster” between 1 Aug – 3 Sep 1818 as “William Stanton and Family”.

- Pg. 216, 3rd paragraph – The **parents** of William [b. 1775] were William Stanton [bapt. 28 Nov 1736 in Chester, England, bur. 9 Nov 1814 in Chester, England] and Ann Edge [bapt. 9 Nov 1735 in Chester, England, bur. 1 Mar 1818 in Chester, England]. Nottingham is the ancestral home of the Stauntons in England, but there is no evidence to date that “our” branch is connected with them [or any of the historical Staunton figures that Rev. Staunton and Edwin Craig mention in their writings].
- Pg. 216, 3rd paragraph – Edwin Craig [pg. 43] gives 2 possibilities for William’s [b. 1736] wife’s maiden name: Anne Parry or Anne Shone. Edwin [pg. 71] again gives the 2 possibilities, but lines through “Parry”, as though to indicate that he had settled on “Shone” as her name. You have spelled the surnames “Perry” and “Strone”. Neither William [b. 1775], William [b. 1803] nor Edwin ever mention that William [b. 1736] had two wives:
 - Anne Parry [b. abt. 1740, d. bef. 4 Nov 1771], m. 3 Oct 1765 at St. John the Baptist Church, Chester, England. Anne had a daughter:
 - Elizabeth Stanton [b. bet. Jul 1766–Apr 1767, bur. 4 Apr 1767]
 - Ann Edge [bapt. 9 Nov 1735, bur. 1 Mar 1818], m. 4 Nov 1771 at St. Mary’s-on-the-Hill Church, Chester, England. Ann had three sons:
 - Boy Stanton [b. & d. abt. 1773]
 - William Stanton [b. 11 Jan 1775, d. 27 Sep 1844]
 - Thomas Stanton [b. 14 Apr 1778, d. “in his youth”]
- Pg. 216 – ADD – The **grandparents** of William [b. 1775] were John Stanton [bapt. 5 Jul 1716, bur. 11 Apr 1774] and Ann ??? [b. abt. 1714, bur. 25 Feb 1789], m. in abt. 1735. They had 8 children:

- Pg. 217 – Thomas was still alive on 1 Aug 1878, according to Edwin Craig.
 - BTW, Thomas was conceived in late Feb-early Mar, 1814, 2 months before Elizabeth Powell Stanton died.
- Pg. 217 – Thomas, 4th and 5th paragraphs – The name “Joseph” should be “Thomas”.
- Pg. 217, 221, 222-223 and 237 – only Thomas was born in England. Anne Eliza, Mary Jane, and Henry were born in Pennsylvania, after William and Mary Evans Staunton had emigrated in 1818.
- Pg. 219, 221, 238 – Matthew Henry Staunton [b. 23 Sep 1831, d. 10 Mar 1915], m. Mary Teresa DeForest [b. Nov 1833, d. 2 Oct 1907] on 12 Mar 1854.
- Pg. 219, 221, 225, 238 – Edwin Adolphus Staunton [b. 28 Aug 1834, d. 17 Jun 1906], m. Jane C. Barrett [b. 17 Mar 1839, d. 30 Jan 1915] on 28 Dec 1858.
