THAT we, the undersigned, are severally held and bound unto the County of Allegheny, in the State of Pennsylvania, and its successors, in the sums set opposite our names: to the payment of which well and truly to be made do, each for himself but not for the others, bind ourselves, our heirs, executors and administrators, firmly by these presents.

WITNESS our hands and seals this 31st day of March, A.D. 1908.

WHEREAS, proceedings have been duly had in the Court of Quarter Sessions of the County of Allegheny at No. 6 September Sessions, 1906, of said Court, authorizing the erection and construction of a county bridge over the Ohio River between the Borough of Sewickley and Moon Tonwship, as by reference thereto will more fully appear: and

WHEREAS, the Commissioners of the County of Allegheny have requested the undersigned to become responsible, each to the amount set opposite his name, for the consequental damages which may be recovered against the said county in certain proceedings instituted by the owners of property affected by the location of said bridge, in which damages have been allowed by the viewers appointed in said proceedings, as follows: Cornelius B. Todd, \$7,000; W. H. S. McKelvey, \$5,000; Louisa Wormwood \$2,000; and

WHEREAS, appeals have been taken by said persons, which are pending in the Courts of Common Pleas of Allegheny County; and

WHEREAS, the undersigned are willing to idemnify the County of Allegheny to the amounts set opposite their names and it is agreed that they shall be severally held responsible to contribute pro rata, according to the amounts subscribed, to the payment of all consequential damages that may be recovered in said proceedings; and

MMEREAS, it is agreed for the purpose of diability upon this bond that the direct damages due to the taking of the land actually occupied shall be \$9670.00, and the liability of the undersigned shall be for their pro rata amount not exceeding the sum of \$10,000 that may be recovered in said proceedings.

NOW, THEREFORE, THE CONDITION OF THIS OBLIGATION IS SUCH, That if the undersigned shall idemnify and save harmless the County of Allegheny and its successors and shall upon demand pay over to the Commissioners of said County pro rata the amount of the Jamages in excess of the said sum of \$9670.00, but not exceeding their pro rata shares of the num of \$10,000, then this obligation shall be void; otherwise shall be and remain in full force and virtue.
